Call to order: 1902h

Social Program

Gary Notar addressed the Board with observations, concerns and suggestions regarding the Social Program, specifically the Friday Night BBQs:

- a rough estimate of the man-hours required for a smooth Friday BBQ is 35-40
- Friday BBQs use approximately \$1000 worth of items such as paper plates, plastic cups and cutlery, napkins, coffee, tea, etc... there should be funds immediately available to whomever is organising a BBQ so they are not paying out of pocket
- each BBQ should have a \$200 float to make change
- the hired staff should be available between 1:00pm and 9:30pm on Fridays to assist with the BBQs
- the ticket price should be the same for everyone; guests should not be charged more than members
- an example menu was distributed showing a projected profit of \$1.00 per plate, based solely on the cost of food
- Board members are to consider the presentation for further discussion at the next meeting

Directors Reports

Membership:

- the intake process for new members is being modified; interviews will be conducted throughout March and not again until the fall
- when there is a wait-list for docks, applicants with boats will go on the wait-list as Social members
- reported several cases where applicants were approved for membership in a prior year and didn't submit fees at that time but are expecting to still be on the wait-list; if an applicant is approved for membership, payment must be received by May 30 of that year, and by the usual deadline in subsequent years, in order to remain on the wait-list
- approximately 50 people attended the Open House last month, resulting in 28 new applications for membership
- is planning a Pancake Breakfast for new members on June 10th from 0900 to 1130; the annual Commodore's Cup race is the same day; Dee Vanzon has volunteered to head up the breakfast preparation
- the Club should try to recover the amount paid to Rentex for the boat show booth (as it wasn't available this year), in addition to any LSYC-branded items that Rentex may have; Don and Brayden will attempt to contact them

Environment:

- distributed a drawing showing the location of the settling tank for the Storm Water Management Project
- the shrink-wrap bin will be arranged for delivery early in April

Property:

Randy Guthrie has drawn up some plans for the kitchen expansion which would see west wall moved out, the
under-counter freezers removed and the kitchen island extended four feet; this is a major undertaking and likely
will have to wait until next winter

 Sophie, one of last year's staff, is coming is when she is available; Bill to ask if she would consider mentoring any new staff this year

Fleet:

- is working with Brayden on the LSYC website changes that would incorporate a database back-end for member's information, with the goal of giving each member the ability to change their contact details, view work hours, sign up for work parties, etc...
- still looking for someone to arrange cruises this summer; there are a number of incoming cruises but few outgoing ones yet
- Racing calendar has been set and is now available on the website

Treasurer:

minor billing issues to be sorted out; several members reported not receiving invoices

Rear Commodore:

- has had many emails from members concerned about the increase to work hours
- there is a need to improve the process for recording work hours; changes to the website that would allow team leads to submit and more closely monitor work hours will help
- there was a discussion regarding Etobicoke Yacht Club's launch and haul-out methodology; by employing four self-propelled cradle lifts they have managed to significantly reduce their launch/haulout costs, both in terms of time and crane rental; they have also eliminated the need for the boat hauling trucks and trailers we currently use
- it would be a good idea to have a group of Board members and team leads go to EYC and observe their process,
 and EYC has also offered to come to LSYC and make a detailed presentation on their process to the Board

Vice Commodore:

 the Board agreed to redeem several debentures and refund some of the mooring/storage fees for members who sold their boats part-way through last season
