- request from Kelly and Dana Balyk to host line dancing classes at the club on Tuesday evenings throughout November; the board agreed with the exception of the second Tuesday in November, which is the membership meeting

## **Directors Reports**

Membership:

- has interviewed nine new membership applicants (names to be posted)
- plans for the club's boat show booth are coming together; goal is to have something which is simple to setup and takedown, and requires minimal storage space; cost in the range of \$2000-\$3000

 making arrangments for staff to come in over the winter, likely on Wednesdays and Saturdays for four hours in the afternoons

Rear Commodore:
