Environment:

 reported that the contents of the shrink wrap bin were accepted by the recycling company with no additional fees

 noted that the bin for used oil filters has been found to contain used oil and other fluids; also, better markings are needed on the diesel drum

Membership:

- received a letter from one of the recent membership applicants asking for the Board's consideration in the matter of their vessel, a 42' Jeanneau; there was some discussion of waiving the 40' length limit in this case, as the vessel can be moved on a trailer anywhere in the yard
- Motion: by Sean Furniss, to grant an exemption to the length limit in the event that the applicant, P. Hewlett, is accepted for membership at the end of 30 day posting: carried
- the wait list has grown to 40 applicants, most of them for Social membership; the Board agreed to close membership applications for the remainder of this year (with discretion)
- Motion: by Lynn McFerran, to accept for membership the three applicants whose names were posted last month: carried

Harbourmaster:

- received a boat change request from E. Castro; his current dock is suitable for the new boat
- Motion: by Graham Mackey, to accept the Castro boat change request: carried
- received a request from G. Romani for slip reassignment to the outside of A dock, where there is an empty slip the same size as the one he's in now; it is currently designated as a visitor slip as the member it is assigned to has paid full fees but hasn't had a boat in it for two seasons
- Motion: by Sean Furniss, to reassign G. Romani to the vacant slip on the outside of A dock;
 carried
- reported a work party is being arranged for the middle of the month to address dock stability issues
- concrete blocks in the basin still need to be moved and a flood light with motion sensor remains to be installed
- dock numbers need to be repainted at the ends of many of the fingers

Treasurer:

- has arranged for four summer staff, one starting May 15 and three starting June 26
